

Consent form for reproductive cell or embryo destruction and transferral (reference example)

2. Physician's statement

(1) I have endeavored to explain in the way that the consenter could understand the content of Article 21 of the “Assisted Reproduction Act”, regarding the criteria that are involved in reproductive cells and embryos destruction where one of the following conditions is satisfied:

1、Donated reproductive cells

- (a) The recipient couple has completed one live birth using the donated cells
- (b) The cells have been preserved for more than ten years.
- (c) It has been discovered after donation that the cells are unsuitable for use in assisted reproduction.
- (d) If the assisted reproduction institution terminates its business operations.

2、Recipient couple's reproductive cells

- (a) The providers of the reproductive cells have asked for destruction
- (b) The providers of the reproductive cells have died.
- (c) The reproductive cells have been preserved for more than ten years, but the preservation period may be extended to the date assigned by the providers of the reproductive cells if their written consent is obtained.
- (d) If the assisted reproduction institution terminates its business operations.

3、The embryo created for the recipient couple

- (a) The marriage of the recipient couple is invalid or annulled, the couple divorces, or one of the spouse has died.
- (b) The embryo has been preserved for more than ten years.
- (c) The recipient couple has given up attempting assisted reproduction.
- (d) If the assisted reproduction institution terminates its business operations.

(2) I have endeavored to explain in the way which the consenter could understand

the content of Article 21 of the Assisted Reproduction Act, that the reproductive cells or embryos preserved by an assisted reproduction institution should be destroyed if the assisted reproduction institution terminates its business operations; however such donated reproductive cells may be transferred to another assisted reproduction institution with the donor's written consent. The recipient couple's reproductive cells or embryos may be transferred to another assisted reproduction institution for continued preservation with the recipient couple's written consent.

(3) I have given sufficient time to the consentor to ask the following questions involving reproductive cell or embryo destruction, transferral, and have provide the answers accordingly

3. Statement from the donor or the recipient couple

(1) The doctor has explained to me, and I have understood, the regulations in Article 21 of the Assisted Reproduction Act regarding the criteria that are involved in reproductive cell and embryo destruction. Among which paragraph 2 subparagraph 3, when the reproductive cells for the recipient couple have been preserved for more than ten years:

- I have agreed to destroy the reproductive cells according to the law.
- I have agreed to extend the preservation period.

(2) I understand that when assisted reproduction institution terminates its business operations, the reproductive cells that are acquired from the institution are required to be transferred to another Assisted Reproduction Institution. The reproductive cell or the embryo for the recipient couple will be required to be transferred to another Assisted Reproduction Institution. I have agreed for one of the following means of management in situations where the assisted reproduction institution terminates its business operations:

- I agree to authorize the institution to transfer the reproductive cells to another Assisted Reproduction Institution for continued preservation.

- Please ask the institution to contact me in person. If I am unable to be contacted, I agree to authorize the institution to transfer the reproductive cells to another Assisted Reproduction Institution for continued preservation.
- Please ask the institution to contact me in person. If I am unable to be contacted, I agree to destroy the reproductive cells according to the law.
